## ROADWAY CONCEPTUAL ANALYSIS PUBLIC MEETING

Orange County is moving forward with a Roadway Conceptual Analysis (RCA) Study for the planned widening of Chuluota Road from Colonial Drive (State Road 50) to Lake Pickett Road. The planned improvement would create a four-lane divided roadway within the project limits. After gathering public feedback, the project team is ready to move forward and give the public a look at the design recommendation for this project.

The RCA Study involves significant data collection, including current and future traffic volumes, current and future land use along the corridor, and right of way needs. The study also involves thorough environmental analysis to evaluate potential impacts to protected and endangered species, wetlands, or other natural resources.

The recommended plan would provide four 11-foot-wide travel lanes separated by a 22-foot-wide raised, landscaped median along with two stormwater treatment ponds and two floodplain compensation ponds. The improved corridor would also have a 10-foot-wide shared-use path on one side of the road and a 6-foot-wide sidewalk on the other. The sidewalk and multi-use path would be separated by 4-foot-wide grassed buffers. The project would accommodate the future East Orange Trail on the east side of the road north of The Preserve at Cypress Lakes.

Orange County welcomes public input and invites the community to learn more at the second public meeting on **Monday, December 5, 2022, at Corner Lake Middle School Cafeteria, 1700 Chuluota Road, Orlando, FL 32820**. An open house will begin at 5:30 p.m., followed by a presentation at 6 p.m. Orange County will review all input and then provide the recommendation to the Orange County Board of County Commissioners about whether to move forward with the project.

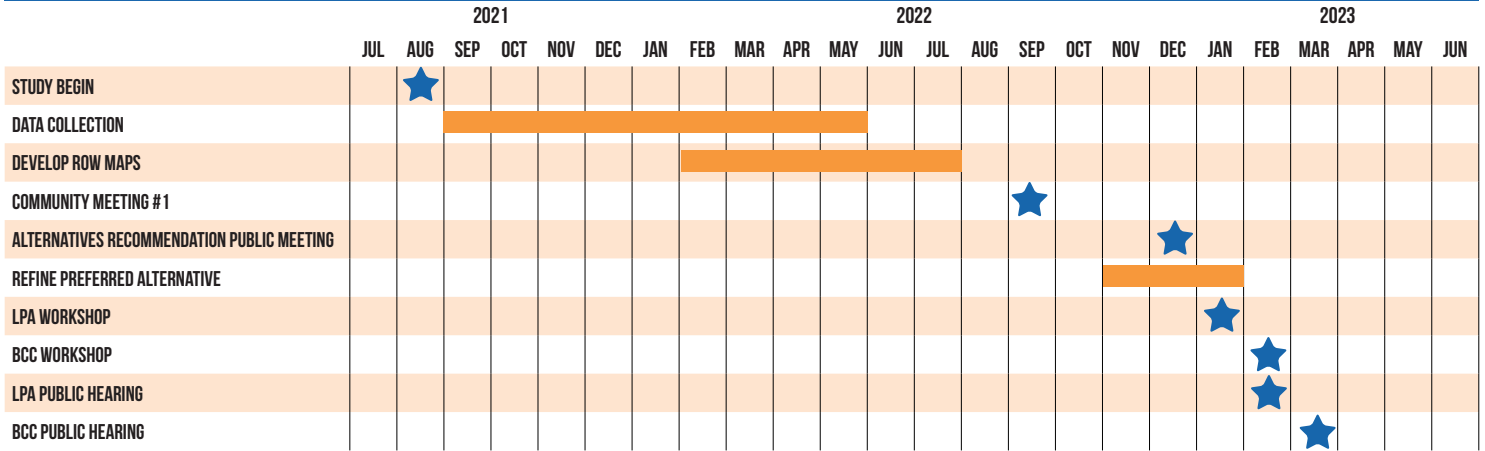

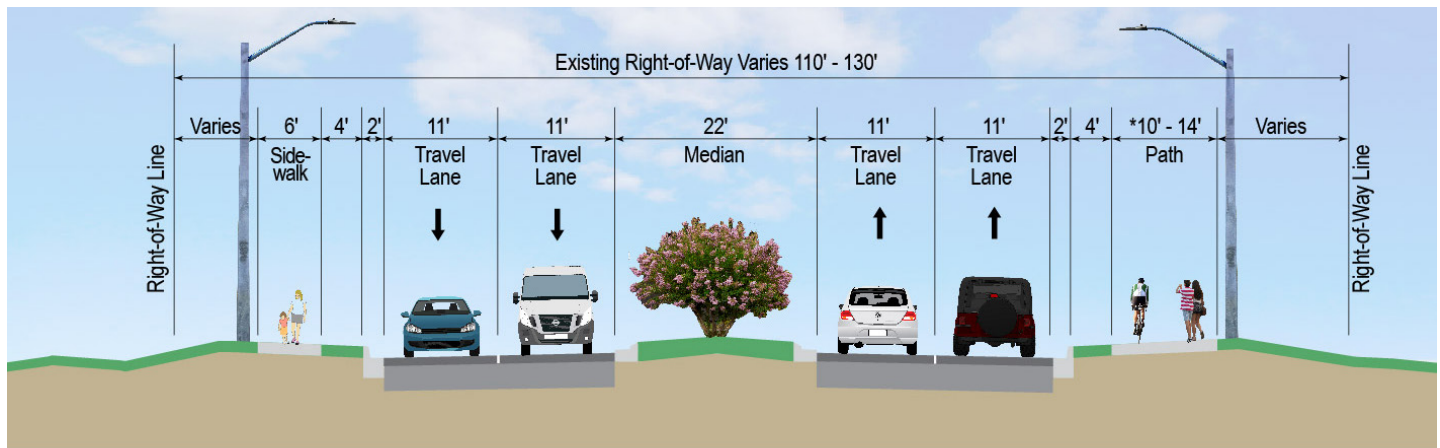
